The retiring Chairman paid tribute to the Duke and Duchess of Sussex, congratulating them on the birth of their new son.

Reverend James Hutchings gave short prayers to give God's blessing for the Council's coming year.

The retiring Chairman welcomed fellow Councillors, invited guests, families and members of the public to the meeting.

PUBLIC FORUM:

Councillor E Wragg was invited to speak during public speaking time. She asked that the new Council be open and fair and enables all members to speak in full when debating matters. She also asked that the Town Council considers very carefully any requests to take on responsibilities that are to be passed down from principal councils. There was concern that this could lead to an increase in the precept and result in taxpayers being burdened with additional costs.

C19/029. ELECTION OF MAYOR/CHAIRMAN

Councillor T Dumper proposed, and Councillor B Toye seconded, that Councillor S Gazzard be elected as Chairman (Town Mayor) of Exmouth for the ensuing municipal year.

No further nominations were received.

Following the nomination, a vote was taken and Councillor S Gazzard was duly elected as Town Mayor and Chairman of the Town Council for the ensuing year.

RESOLVED that Councillor S Gazzard be elected Mayor and Chairman of Exmouth Town Council.

Councillor J Trail passed the Chain of Office to Councillor S Gazzard and a round of applause followed.

C19/030. APPOINTMENT OF DEPUTY MAYOR AND VICE-CHAIRMAN

Councillor D Poor proposed, and Councillor A Bailey seconded, that Councillor B Bailey be elected as Deputy Town Mayor of Exmouth for the ensuing municipal year.

No further nominations were received.

Following the nomination, a vote was taken, and Councillor B Bailey was duly elected as Deputy Mayor and Vice-Chairman for the ensuing year.

RESOLVED that Councillor B Bailey be elected Deputy Mayor and Vice-Chairman of Exmouth Town Council.

Councillor B De Saram passed the Chain of Office to Councillor B Bailey and a round of applause followed.

Adjournment - A short adjournment followed which allowed the robing of the new Mayor.

The Town Crier, Roger Bourgein, asked the room to be upstanding and the current Mayor and Deputy Mayor were led into the room and to their seats.

The newly-elected Chairman and Mayor welcomed fellow Councillors, former Mayors, invited guests, family and members of the public to the meeting.

The Chairman made a short acceptance speech by congratulating all those that had been successfully elected to the Town Council. He also thanked those who were not successful and hoped they would try again at the next election.

The Chairman dedicated the meeting to his late daughter Sarah and late son Sean, as without their encouragement he would not have considered becoming a councillor.

He asked that members support him, the town and his chosen charities by working together for the benefit of the electorate and the town.

The Chairman and Mayor gave a vote of thanks to the out-going Mayor, Councillor J Trail, who had worked admirably for the town and for his work on behalf of his chosen charities. The new Mayor presented Councillor J Trail with a past mayoral badge and a scrap book of his time as Mayor. He also presented Sue Trail with a bouquet of flowers in recognition of her support as Councillor Trail's consort.

The Chairman also thanked Councillor B De Saram for his hard work and dedication as the Vice-Chairman and Deputy Mayor.
