Refill	<p>MR updated members on work he has done throughout Exmouth, which included checking all Refill Stations on app were up to date.</p> <p>The Tourist Information Service is now a Refill Station. Tourist Information Volunteers to be made aware of the Stations in Exmouth so they can let visitors know. Possibility to include links on the ETC website to be investigated.</p> <p>Currently, there are Refill Devon posters displayed in ETC's Magnolia Kiosk and ETC reception. #### **4. Priorities of Working Party, in line with the Terms of Reference (ToR)**

The group discussed the current priorities of the Working Party and agreed, as a good starting point and in line with the ToR, to include:

- Achieve Surfers Against Sewage accreditation
- Focus on improving the street waste recycling in public bins
- Investigate possibilities of installing water fountain/water bottle filling stations
- Investigate possibilities of installing a sculpture which visually shows the impact of waste
- Current campaigns, schemes and ideas members may wish to share.

These ideas will be included as standard agenda items until action has been met i.e. sculpture is installed.

## **5. Update on ongoing items**

### **Waste Audit**

Two public recycling bins have been installed in the Magnolia Centre, in addition to the general waste bins already there. As these bins are poorly labelled, another waste audit including these new recycling bins may show some interesting findings. The data collected through these audits could be provided as evidence to help shape EDDC's public waste policies to increase the amount of waste collected that can be recycled. EDDC Street Scene were in support of improving the street waste recycling rate.

**Action: AS to contact EDDC Street Scene to organise another Waste Audit.**

The Greendale recycling facility was raised as a potential facility to sort and recycle public bin waste.

**Action: BB to provide CJ with contact details of the manager of Greendale so that they can be contacted for further information and potentially invited to a future meeting, along with EDDC Street Scene.**

### **Surfers Against Sewage**

AS provided an update on behalf of TD confirming that the Exmouth Transport Partnership Group has applied for funding to improve the Train Station area. If approved for funding, there may be scope to install a water fountain/bottle filling point in the area.

### **Fish Sculpture**

JW confirmed that planning permission would need to be applied for to install a sculpture but that Chris Rose in the EDDC Planning West Team is keen on the idea and is happy to liaise between ETC and EDDC Planning.

TW added that Charlie Plowden from the EDDC Countryside Team has asked for ideas for a community project to be completed in 2020.

**Action: JW to contact Charlie Plowden to find out if this sculpture could be considered and update members as and when information is available.**

If this idea is not considered for the EDDC Countryside Team's project, members to come up with some ideas for locations and funding options for the next meeting.
